On 9 May 2019, at the HERA Awards, Marguerite Vanhee presented the Albert Vanhee Fund for Future Generations, which she had just created within the Foundation.



On 25 February 2019, the Parliament of the German-speaking Community, with the support of the G1000, voted unanimously to involve randomly chosen citizens in political decisions on a permanent basis.

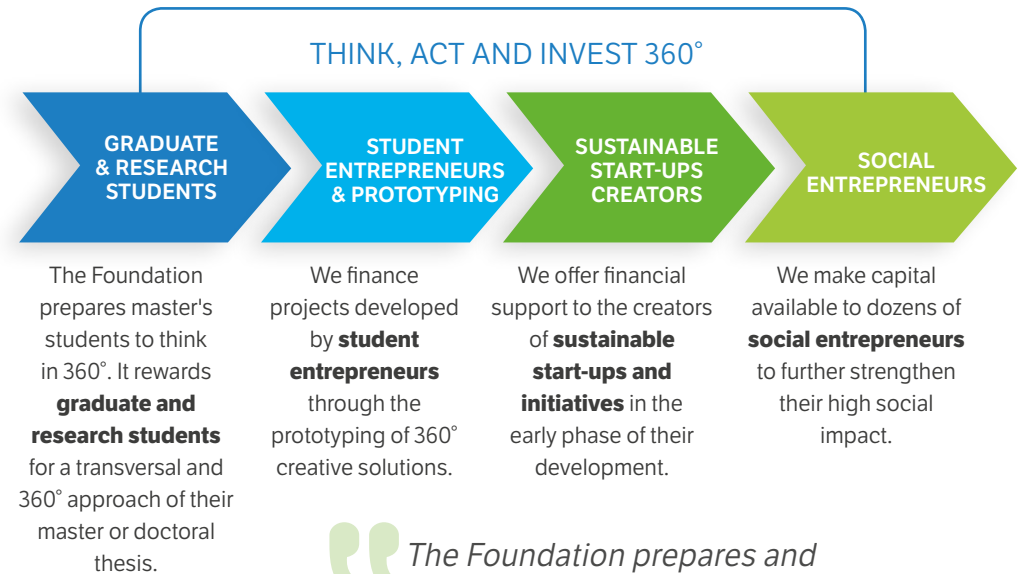

Young graduate and research students who think of tomorrow in 360°

"I am delighted with the ceremony tonight, which is for us a source of emulation, dialogue and inspiration", **Pierre Jadoul**, Rector Université Saint-Louis - Brussels.



"It is a complex issue for universities to combine both excellence in research, leading to increasingly specialised fields, and the obvious need for integration, certainly in the field of sustainable development. The challenge is to recruit talents who are capable of opening up to several disciplines and combining them. This is key for the world of tomorrow, and the HERA Awards showcase this really well", **Yvon Englert**, Rector of the Université libre de Bruxelles.

Due to the circumstances linked to COVID-19, the 24 young graduates receiving the HERA Awards 2020 were showcased as part of the "HERA Awards 2020 #StayHome #StayInspired" virtual campaign, symbolically hosted by the ULB.

Working conditions in agriculture have been problematic for centuries. Can agroecology help to improve these conditions? This is the question **Antoinette Dumont, winner of the HERA Doctoral Thesis Award 2019**, explored in her research work. The jury, chaired by **Natacha Zuinen**, underlined her nuanced insights that are very relevant for developing an agroecology that builds on the realities of today to truly propose a model of social justice.

Jean-Claude Englebert, winner of the HERA Award Sustainable IT 2019 set about to assess the environmental impact of blockchain technology, which notably underpins the Bitcoin and Ethereum cryptocurrencies. He also incorporates in his analysis the questions of governance and ethics. The jury, chaired by **Olivier de Wasseige**, underlined the timeliness and relevance of this work, which deserves follow-up.

Using water from Walloon quarries to store energy and therefore offer a solution to the intermittence of renewable energy production. That is the proposed innovation of **Chloé Ponsart, 2020 winner of the brand-new HERA Award Sustainable Engineering**, set up with the support of the Albert Vanhee Fund for Future Generations. The jury, chaired by **Géraldine Tran**, praised the pragmatism of the solution and highlighted its economic viability and industrial feasibility.

Belgian citizens' lack of interest and mistrust in the current political model is reflected during elections by the many blank, invalid and absent ballots. To rekindle democracy at the local level, **Julie Delvoye, winner of the HERA Award Sustainable Democracy 2020**, suggests taking these (non-) votes into account by allocating a number of seats in local government to citizens drawn at random. The jury, chaired by **Yasmine Boudaka**, applauded this innovative and legally feasible scheme.

HERA contributes to 360° university courses

Workshops →

The HERA team organises ten to twenty workshops every year in the country's six French-speaking universities. These workshops are centred around the four dimensions of sustainable development (people, prosperity, the environment, participatory governance) and within the framework of the 17 Sustainable Development Goals.



"Teaching Finance" workshop

Around one hundred participants debated the issue of sustainable finance education with a panel of experts comprising David Pitt-Watson (UK - renowned thinker, author and practitioner), Christel Dumas (BE - ICHec Brussels Management School) and Luc Van Liedekerke (BE - KULeuven and AMS). With the support of the Foundation, a group of experts continued the discussion at the annual conference of the Global Research Alliance for Sustainable Finance and Investment at the University of Oxford.



Contribution to ARES

ARES The Foundation chaired one of the two working groups of the Orientation Council of the Academy of Research and Higher Education (ARES). The working group oversaw the drafting of an opinion on the mission of higher education in supporting students in their role as responsible citizens and in promoting their autonomy and development.

Student entrepreneurs in the prototyping phase who innovate in 360°



The Foundation encourages and supports sustainable 360° innovation among student entrepreneurs. We boost a crucial phrase in the creator's journey, namely prototyping - a key stage during which an experimental version of a product or a process is produced to test and validate how it works.

With grants of up to €5,000, the Foundation wants to create leverage and bring these young entrepreneurs much closer to the ready-for-market stage of their sustainable invention. Among these innovations - some of which you can read about here - we have seen responses emerge to three societal challenges:

Shifting our energy consumption models



Lola and Nathan, student entrepreneurs in civil engineering (UMons) and management engineering (UCLouvain FUCaM Mons), founders of **Waste End**, received funding for the prototyping of a solution to **transform organic food waste into green energy (biogas) and natural fertilizer**.

Promoting a more circular economy tending towards zero waste



Adélaïde, Laetitia and Fiona, student entrepreneurs in civil engineering (UCLouvain) and founders of **Greenzy**, received funding for the prototyping of an indoor composter for private consumers. Simple to use, stylish and easily integrated into a kitchen, Greenzy **grinds and mixes organic material to effortlessly obtain odourless soil**.

Making life easier and safer for the most vulnerable



Lionel, Maxime and Jérôme, entrepreneurial students in industrial engineering (HELMO Gramme, Liège) and founders of **Bootrek**, received funding for the prototyping of a **wheelchair that allows people with disabilities to hike in the countryside**.



Thijs and Tijl, student entrepreneurs at Howest, received funding for the prototyping of **Baggies, reusable bread bags made of hemp** as an alternative to millions of single-use bread bags, whose paraffin content prevents recycling.

THE ENVIRONMENT FEDERAL MINISTER IN SUPPORT OF ZERO WASTE



As part of her action to raise awareness of key sustainable development issues, the Federal Minister for the Environment supported in 2019 and 2020 two calls for projects that highlight alternative approaches in the fight against waste. The resulting 15 initiatives in 2019 (as part of the Zero Waste Student Challenge) and 7 initiatives in 2020 (as part of support for student entrepreneurs) subsequently received support in the form of a grant, rewarding their innovative approach.

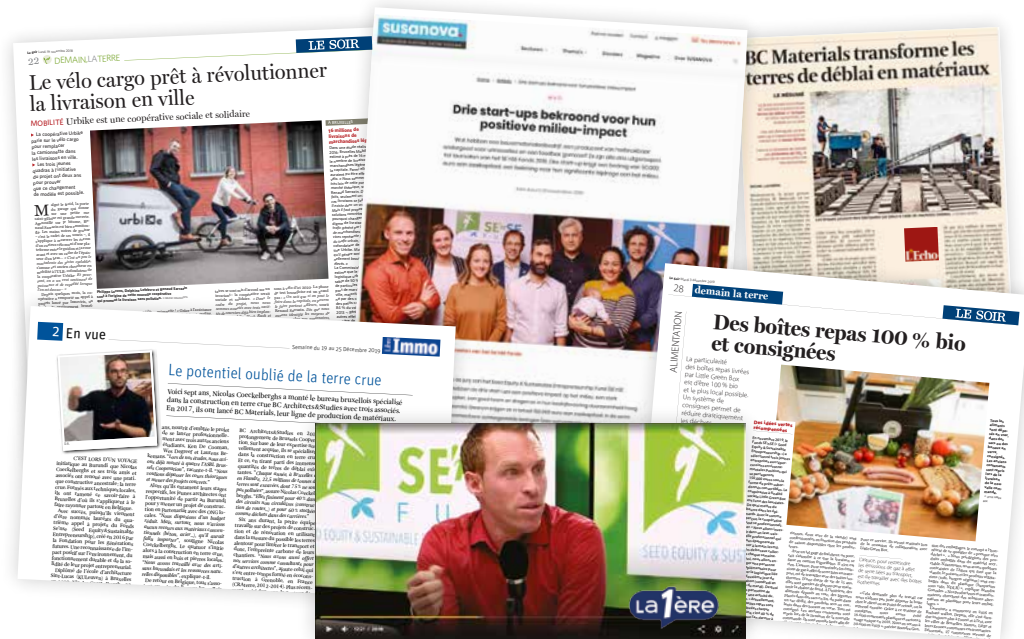

The SE'nSE Fund, created by Pierre Mottet, who was later joined by other patrons, is now in its 5th call for projects for start-up entrepreneurs. Since 2016, 15 initiatives have been selected for their transformative environmental scope by a jury of experts. They received financial support in the form of seed capital - up to €50,000 per project - as well as benefitted from increased visibility and networking.

Start-ups with positive societal impact



Focus on resilient and impactful entrepreneurship
From green energy to sustainable food, from construction to textiles and the circular economy, the winners of the SE'nSE Fund demonstrate that more and more entrepreneurs

care about maximising their positive societal impact. Absorbing some of the risks with them in order for their initiative to thrive is, for the Foundation and those who support it, a way to invest and believe in the emergence of a more sustainable and resilient economy.

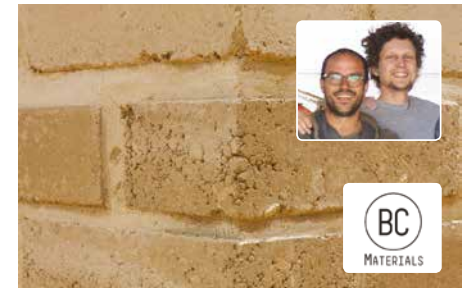
Philippe, Delphine and Renaud, young entrepreneurs and founders of the **urbike** start-up (Brussels), received funding for their cooperative, which promotes the delivery of goods by bicycle in the city. The aim: **to combine decent jobs with digital innovation and logistics** (bicycle containers).



Szandra created the **Little Green Box** cooperative to offer **meal boxes made of local, organic, seasonal products using a zero-waste approach** that avoids single-use containers. The recipes are designed with children in mind to involve them in developing a more sustainable way of life.



Hans and Marie, young entrepreneurs and founders of the start-up **Entusia** (Flanders), received funding for the development of their business, which sells **elegant and reusable underwear for light bladder leakage**. The products are made from bamboo and Tencel, sustainable materials that ensure very good absorption, comfort and discretion.



Ken and Nicolas, founders of **BC materials**, are **giving a second life to soil excavated** during building works by transforming it into new construction materials or coatings. With a neutral carbon footprint, a healthy atmosphere in new buildings as well as easy reuse, this is a promising innovation in a key sector of the economy.

GROWING SUPPORT FOR THE SE'nSE FUND

Since 2018, the **Aether Fund for Future Generations** has been committed to helping the creators of sustainable start-ups through a multi-year contribution to the SE'nSE Fund. A great example of mutual underpinning of the funds hosted by the Foundation! In 2020, the **Eurofins Foundation**, whose ambition is to contribute to global health and safety and to the protection of the environment, also supported the call for projects of the SE'nSE Fund.

Social entrepreneurs to safeguard seas and rivers



Leslie and Elodie and their **WeOcean** project, promote and connect **inspiring Mediterranean initiatives for a sustainable sea** via an online platform and documentary.



Francis, Anne-Marieke, Saskia and Philip have created **The Great Bubble Barrier**, an **innovative method that uses a bubble curtain to stop and catch plastic waste** present in rivers and canals in the Netherlands.



With the support of fishermen, project **Gildas**, **nominated for a HERA Award 2017**, is **reconstructing marine habitats for the preservation of the Malagasy coral ecosystem** and economic development of the region.

THE AETHER FUND FOR FUTURE GENERATIONS

The fund supports sustainable initiatives in the **protection of aquatic environments**, offering assistance over several years to promote their sustainability. It also supports graduate & research students who are recipients of the **HERA Awards** (see p.6) and creators of sustainability start-ups under the **SE'nSE Fund** (see p.12).

In collaboration with the Provinces of Namur, Luxemburg, Hainaut and Walloon Brabant, the Foundation rewards great local initiatives that demonstrate a 360° impact. A way to promote and connect local change actors!

Provincial Award for Sustainable Development



Vents du Sud, winner of the 2018 Godefroid Sustainable Development Award in the Province of Luxembourg, is a **cooperative** in which members can invest according to their needs and become consumers of the output their investment is helping produce. This is done through Cociter, an electricity supply cooperative bringing together 14 citizen cooperatives in Wallonia, including Vents du Sud. The result is a **more direct energy distribution network between producers and consumers that is managed by citizens** to avoid price volatility.



The Saint-Pierre Clinic in Ottignies, winner of the 2019 Incidences Award of the Province of Walloon Brabant, innovates with its "**Hospital in transition**" approach, coordinating the implementation of innovative methods to reduce its environmental impact. The objective of the approach is fourfold: promoting technologies that reduce energy or materials needs, developing new tools, demonstrating a positive cost/benefit ratio over the long term, and making it applicable to other hospitals.

EXCHANGE OF GOOD PRACTICES BETWEEN PROVINCES

Since 2013, the Foundation for Future Generations has also been organising meetings and work days, bringing together local representatives concerned with sustainable development to exchange good practices, share experiences and encourage collaboration.

「The capital which the Foundation can allocate is invested in funds that correspond to our values. Since the start, the Foundation has also chosen to invest part of its capital in the form of direct equity investments in businesses that are significantly committed to sustainable development.」

Socially responsible investments

The Foundation has developed a socially responsible investments (SRI) portfolio based on strict societal criteria and with a long-term perspective. Its strategy is inspired by a benchmark of pioneering European foundations, carried out as part of the Foundation 3.0 programme (see p.27).

In addition to long-standing investments with Triodos, we encourage other asset managers to respond to our investment strategy as we have chosen to keep large donations within their banking ecosystem. A “test-lab portfolio” of shares was thus developed at BNP Paribas-Fortis, combining several extra-financial ratings.

Our primary societal impact investments

The Foundation finances 23 sustainable economy initiatives in 5 key sectors: energy, food, (micro) finance, fair trade, and construction and real estate. In addition, some funds hosted by the Foundation

invest in sustainable initiatives that were selected during a specific call for projects. This is the case with the SE'nSE Fund (see pp. 12, 13 and 23).



EcoPower is the largest citizen energy cooperative in Belgium. With tens of thousands of cooperative participants, including the Foundation, **it produces 100% renewable local energy** and supplies Flanders. The cooperative brings together people who collect electricity from wind, sun and hydropower and produces sustainable green power. The EcoPower participants also try to save as much energy as possible together.



Hefboom offers funding, management advice and services to companies and organisations active in the social and sustainable economy sector, as well as to people who want to start their own business but do not have access to credit and finance. Hefboom is an **intermediary between cooperative investors** - individuals and organisations, including the Foundation - and **professionals in the social and sustainable economy** in Flanders and Brussels.



F'in Common is a cooperative, social economy fund in which citizens can invest their savings. The Foundation, through its Sustainable Finance Fund, provides a guarantee of €150,000 that partially covers the risks incurred, thereby contributing to the financial security provided to these citizen-investors. The Foundation is also a co-founder of F'in Common, alongside Financité and another 30 or so social economy companies.



NewB wants to become the first Belgian bank to be at the same time socially responsible, cooperative, ethical and sustainable. In 2019, NewB submitted an application and was registered as a credit institution before launching a large capitalisation campaign. The cooperative successfully raised €35 million in 6 weeks! After years of hard work, doubts and challenges, NewB obtained a banking licence at the end of January 2020.

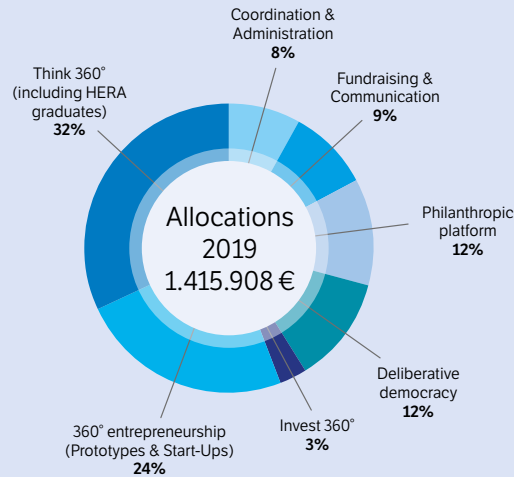
2020: 100,000 Swiss francs were invested in the form of a convertible loan to support the development of the Swiss start-up Clearspace, specialising in the recovery of space debris.

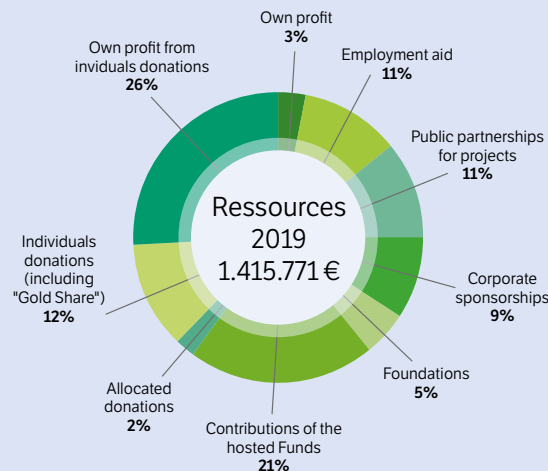
How do we allocate the funds we receive?

Young graduates now represent almost a third of our beneficiaries, a number that has grown steadily over the past decade. Although young (future) entrepreneurs, creators of prototypes and 360° start-ups are a more recent focus, these already received a quarter of our resources in 2019. In addition, activities linked to deliberative democracy, which the Foundation has been concerned with for more than 20 years, mobilise more than a tenth of resources, allocated mainly to the actions of the G1000.



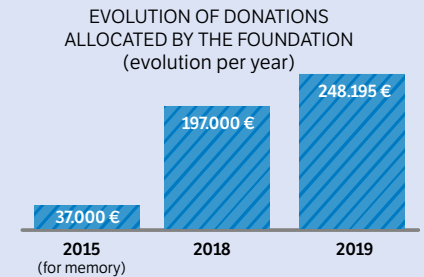
You give us the means to act!

In 2019, nearly two-thirds of the Foundation's financial resources - which are also increasing - came from you, individual donors and patrons, through hosted funds! Further strengthened by the contribution of partner companies and other foundations, you therefore guarantee our independence and give us the capacity to support more and more projects. The contribution of public authorities represents just over a fifth of our resources and remains stable.



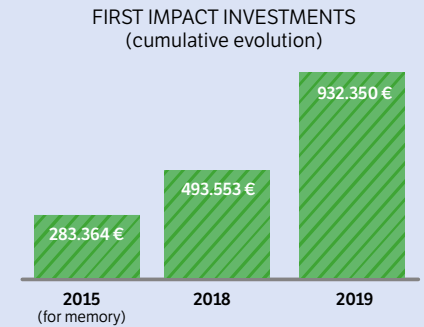
Strong growth capacity to provide financial support

The increase in the number and total amount of financial grants by the Foundation is now secured beyond 2019 (see pp.18-19). We can only continue to offer this extra leverage to the projects thanks to the ever-increasing number of those who trust and support the activities of the Foundation.



Using financial capital as a boost for 360° transformation°

The Foundation has made the rare choice of investing a majority of its financial assets in primary impact businesses (see pp.16-17). Since 2015, this decision has been strengthened, along with the growth of our financial assets, to flourish during the recent subscription campaign of the recently launched NewB bank. Today, this "portfolio" of 23 initiatives, symbols of an ethical and sustainable economy, measures nearly one million euros.

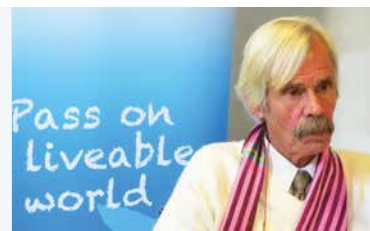

The Future Generations Summit, a meeting place for a vibrant community of changemakers



This event was the perfect illustration of the Foundation's desire to "open up the worlds", to create links between different stakeholders within a growing community that is mobilised for future generations.



The "Meet the Changemakers" space offered a "giant speed dating" with 29 sustainable initiatives as an original way to meet change agents from the four corners of the country who belong to the vibrant and inspiring community of the Foundation.



Three "Horizon 2030" thematic workshops offered wide ranging views of what education, food and housing could look like in a world that has successfully met the challenge of the 17 Sustainable Development Goals.



The "Transformative Power of Money" conference brought together 370 participants. David Pitt-Watson (UK) shared his vision of a finance that must (re)position itself at the service of society. The members of the panel highlighted the intertwined nature of stakeholders in the financial world, the systemic role of finance and the role that citizens can play in strengthening the transformative power of their money.



Several times a year, the Foundation brings together the CEOs of the 'Business, Innovation and Sustainable Development Circle', a group launched at the end of 2012 and which today has around thirty CEOs from very diverse sectors as members. With the support of the **G1000** and the **Foundation**, the German-speaking Community of Belgium (Ostbelgien) became, on 25 February 2019, the first region in the world to integrate the **permanent participation** of citizens picked at random in political decisions. On this basis, the G1000 also organised a **Summer School** and wrote a **paper covering 15 questions** to guide public authorities in the implementation of citizen deliberation.
